

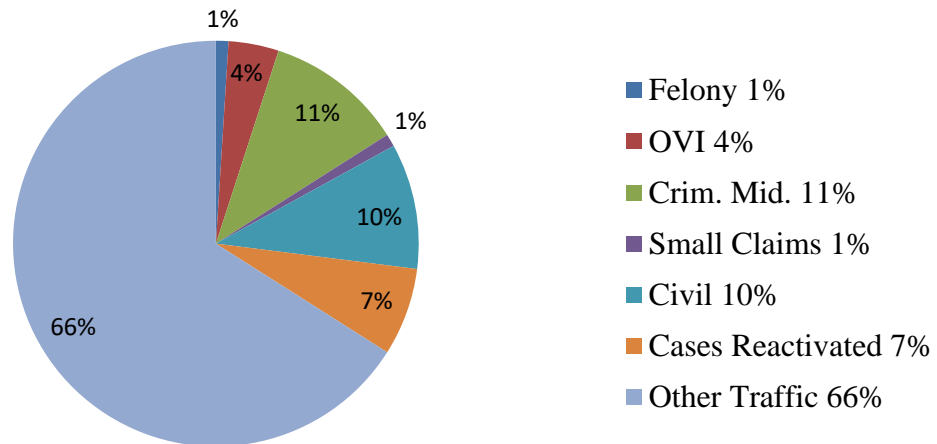
AUTHORITY AND JURISDICTION

The Delaware Municipal Court was created by the Ohio General Assembly in 1952. The Court hears cases from throughout Delaware County, and it has the authority to hear the following kinds of cases:

Felony Cases	- Initial Appearance / Preliminary Hearings
Misdemeanor Cases	- Through Final Determination
Traffic and Parking Violations	
Civil Actions	- Up to \$15,000.00
Small Claims Actions	- Up to \$6,000.00 (eff. September 28, 2016 H.B. 387)
Administrative Appeals	- BMV Cases

The judges preside over civil, criminal, and traffic cases and conduct jury and non-jury trials. In jury trials, the judges interpret the law and the jury determines the factual matters. In non-jury trials, by far the more common, the judges have the dual role of interpreting the law and determining the facts. The judges conduct criminal arraignments and preliminary hearings on felony cases; set bond on criminal charges; issue search warrants; and impose sentence when a defendant is found guilty of a traffic or criminal charge. The judges hear civil cases where the amount in controversy is \$15,000.00 or less. In addition, the judges perform civil wedding ceremonies.

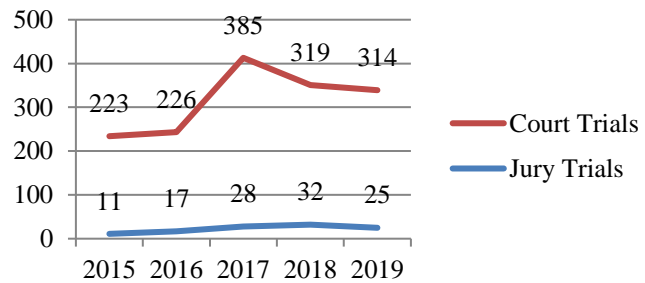

Jury Trials and Court Trials Five Year Comparison



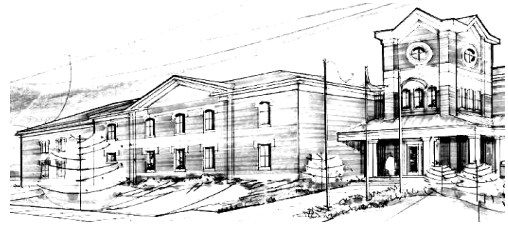
WEDDINGS
